#### Arrangements Regarding the Purchase of Safety Equipment and Restraint Devices for Students

Dear Parents/Guardians,

To ensure the safety and well-being of students on campus and in dormitories, our school, in accordance with the Practical Guidelines on the Planning and Management of Boarding Services in Special Schools issued by the Education Bureau, will address the individual special needs of students (e.g., medical, safety, or behavioral support) through assessments by a multidisciplinary team and positive intervention strategies. However, if these measures do not achieve the desired outcomes, students may, under specific circumstances, require the use of safety equipment or professional restraint devices to ensure their safety. Please be informed of the following arrangements and kindly cooperate accordingly:

#### 1. Policy Objective



To safeguard students' safety, prevent self-harm or accidents caused by sudden emotional fluctuations or behavioral loss of control, and enhance their participation in learning and daily activities, our school, based on individual students' special needs (e.g., medical, safety, or severe emotional and behavioral issues), may recommend the use of specific safety equipment or restraint devices (e.g., safety vests/restraint vests, safety belts, wrist straps, positioning devices, etc.). All such items comply with professional safety standards and are subject to approval by the school's professional team before use.

#### 2. Purchase Arrangements

1. All categories of safety equipment or restraint devices must be purchased at the parents' expense.
2. Parents may purchase certified and compliant products through the school (dormitory instructors or class teachers) as a unified arrangement and will be required to pay the associated costs (please refer to the attached price list for details).
3. The school will maintain regular review the need and usage of such equipment with parents.
